# • New Business

- The water main project, design engineer has submitted 40% of the plans to Denver Water. It's on track, bids in by mid-April. There is one conflict that a mailbox structure needs to be relocated.
- IGA, Tim re-working first page of the agreement, district to receive \$125K at execution of the agreement, work needs to be completed prior to end of 2024. The district will have the right to review bids and has the discretion to move forward or not. The district is responsible for anything above \$125K.
- Cynthia recommending, we use In-liner for the 473 feet to line a segment of the Prospect sewer line. They have done excellent work in the past and have become the default company for smaller jobs. They are \$6,600 over budget but expected with current costs. Motion was approved to move forward.
- Cora Resolution 2024- 2-1 motion was approved. This is an open solution, defines position and what's provided. Setting open records policy.
- Portal discussion seems to be running very smoothly.
